AUTHORIZE THE JOHNSTOWN POLICE DEPARTMENT TO ACCEPT A DONATION OF AN ARMORED VEHICLE FROM THE BRINKS ARMORED VEHICLE DONATION PROGRAM

WHEREAS, Brinks Armored Vehicle Donation Program, in conjunction with the New York Tactical Officers Association, donates armored vehicles to at-need law enforcement agencies; and

WHEREAS, Brinks regularly decommissions vehicles that they no longer use, but are still in good shape; those vehicles are then donated to local law enforcement and municipalities; and

WHEREAS, pursuant to Resolution #48, on April 16, 2018, attached hereto, the Common Council authorized the Johnstown Police Department to apply for the donation of an armored vehicle from Brinks Armored Vehicle Donation Program; and

WHEREAS, the Johnstown Police Department has received notification that they have been awarded a 2016 Armored Vehicle with NIJ-3A ballistic capabilities, VIN #3C7WRMAJ5GG258358.
