Board Member Lyon questioned why revenues are less than expenses. Clerk Koehler explained the estimated Revenue for 2020 is \$1,750,000 and Expenses are estimated at \$5,922,363, creating a short fall of \$4,172,363. \$3,375,000 would be covered by the BAN/Bond for Phase 2 of the Dam Project. The remaining short fall would be covered by funds in our savings account.

Board Member Lyon asked is we have heard anything about the Bonding from the city. Board Vice President Swierzowski stated the city has not communicated with us.

Board Member DiMarco wanted to add another water plant operator to the Employee List. Board Vice President Swierzowski said it was a good idea as New York State has about 37 Water Plant Operators that are retiring in the near future, creating a shortage in the state.

Board Vice President Swierzowski also stated a Trainee should not be paid the same as the person training them. There is no position in the CSEA contract for a Water Plant Trainee.

Board Vice President Swierzowski said he thinks the city has blocked to Water Department from Union Negotiations, unless this is just an unsubstantiated rumor. Board Member DiMarco stated he knows for a fact the city has had two union meetings. Board Member DiMarco advised he heard this first hand from the union shop foreman.
